IAF Updates

- Authentication Working Committee The Device Identification and Authentication project team is working on the first of several whitepapers with a goal of releasing the first by the end of August.
- Mobile Identity Working Committee A sub-committee is completing a charter
 for "Jumpstarting the mDL Ecosystem" which will outline several projects and
 SOWs. "What is an mDL", an editorial for Supermarket News, is nearing completion, and there have been 17 major updates to the mDL Connection Implementation Tracker Map reflecting the increased activity and adoption of mDLs.
- Joint Federal Enterprise Working Committee The committee completed the submission to NIST for the Identity and Access Roadmap.

U.S. Payments Forum Working Committee Highlights and Resources

- The <u>Debit Routing Working Committee</u> published a <u>white paper</u> exploring the technical and operational impacts of the July 2023 Reg II update on various industry stakeholders and sharing considerations for implementation in order to maintain successful transaction processing.
- The <u>Communication & Education Working Committee</u> recently began work on a second webinar on the topic of EMV® Secure Remote Commerce (SRC).
- The Mobile & Touchless Payments Working Committee is working on a new white paper entitled Exploring Data Elements in Mobile and Online Transactions and a new project exploring the role of mobile driver's licenses (mDLs) and other digital identities in mobile payments.
