Alliance sponsorship of SIA GovSummit

The Alliance was a supporting partner for the SIA GovSummit in Washington, D.C. Nearly 300 attended 15 sessions over the two-day event that covered a wide range of topics including FICAM Compliance for PACS, PIV and the Pathway to Federal Digital Identity Standards Adoption, New Era for Biometrics, and Future Proofing Against Cyber-Physical Threats, and many more. Thank you to Alliance members Roger Roehr (Integrated Security Technologies), Lars Suneborn (Identification Technology Partners), and, Andy Farmer, Casey Mayfield, and Teresa Wu (IDEMIA) for representing the Alliance on these panels. Three additional sessions were hosted by the Alliance:

"Supervised Remote Identity Proofing (SRIP) for Today's Security and Operational Needs" covered the process of SRIP and several use cases. Presentations included Michael Harris (NextgenID), John Jacob (IDEMIA), and Bill Windsor (IDEMIA) along with industry experts Adam McBride (HHS) and David Temoshok (NIST).

"Why Federal Agencies Should Leverage ISO 18013-5 Mobile Credentials Beyond Mobile Driver's Licenses" highlighted use cases presented by a panel discussion among 5 Alliance members: Teresa Wu (IDEMIA), David Kelts (GET Group), Ashley Andrews (Defense Manpower/DOD), Tom Lockwood (NextgenID), and Joh Prisky (Homeland Security).

"Using Mobile Devices for Identity Assurance Level 2 Enrollment and Proofing" discussed using mobile technology along with mID to expedite enrollment and proofing while ensuring a secure transaction. Members Jatin Deshpande (Giesecke+Devrient), Justin Legary (IDEMIA), and Tom Lockwood (NextgenID) were joined by Brian Broderick (U.S. Citizenship and Immigration Services).
